

SHIPLAKE NEIGHBOURHOOD PLAN INITIAL SURVEY RESULTS



Dear Residents,

Although we are waiting for the completion of analysis from the data analysts and also our own analysis, I thought that residents might be interested in some of the high-level feedback you provided the Neighbourhood Plan team via the Questionnaire that was recently undertaken.

We had in excess of 700 completed documents back representing over 750 people, and so the response rate was very good and for which we are most appreciative.

Some of the key responses from the questionnaire are below, and once the more detailed analysis is completed we will provide more feedback, and in particular about where people think are suitable sites for any new development to take place.

New Housing in Shiplake Villages:

For the Neighbourhood Plan to be valid, sites for at least 33 houses will need to be identified. There could be one large site, or there could be, say, 5 or 6 sites of 6 or 7 houses – and various other combinations. A key point is that any site of more than 10 houses must comprise 40% affordable housing (see panel below), while there is no such requirement placed on smaller sites.
